**PUBLIC NOTICE, AS A MATTER OF RECORD, AND CLAIM OF DECLARATION OF STATUS****TO WHOM IT MAY CONCERN:**

**1. The undersigned** sentient Man -- hereinafter "Man," will identify a sentient man and/or woman, married and/or single -- claims for the nonpayment of taxes levied on sentient Man's land and appurtenances by a constructive trust done without contract and/or without disclosure of any contract producing the fact that no articles of incorporation exist creating the corporate fiction, legal fiction, or counterfeit or any derivation/deviation thereof that produces an agent for a fiction or a counterfeit person as a corporation sole with or without the use of any trust identification number are hereby cancelled as are all derivations or res of: JOHN NIKOLAUS BECKER, or JOHN N. BECKER (herein after counterfeit).

**2. The sentient man** is not represented by the name in all UPPER case letters with middle initial/middle name, or Upper and Lower case as First, Middle Initial/Middle Name AND last Name identified as res or in rem or any variation of names thereof used as a corporate identifier or legal fiction. "Initials are no legal part of a name, the authorities holding the full Christian name to be essential." Monroe Cattle Company vs Becker, 147 US 47 (1893); Wilson v. Shannon, 6 Ark. 196; Norris v. Graves, 4 Strob. 32; Seely v. Boon, 1 N. J. Law, 138; Chappell v. Proctor, Harp. 49; Kinnersley v. Knott, 7 C. B. 980; Turner v. Fitt, 3 C. B. 701; Oakley v. Pegler, (Neb.) 46 N. W. Rep. 920; Knox v. Starks, 4 Minn. 20, (Gil. 7); Kenyon v. Semon, (Minn.) 45 N. W. Rep. 10; Beggs v. Wellman, 82 Ala. 391, 2 South. Rep. 877; Nash v. Collier, 5 Dowl. & L. 341; Fewlass v. Abbott, 28 Mich. 270.

**3. In order** for this Man to enter into any such contract, He must enter into any said contract with meeting of the minds, knowingly, intentionally, willfully, voluntarily and understandingly to be valid.

**4. For those reasons**, any tax levied on homestead property for any purpose whatsoever violates the separation of powers doctrine as my homestead is declared and protected by a Presidential Executive Order and the privileges and immunities clause of Article IV of the Constitution for the United States of America. A tax of any nature whatsoever discriminates against a sentient man by placing him in a status of involuntary servitude and that I as Man, thereby, declare a fraud by the corporate state, as said state gives only a title in equitable interest to any said land and land's appurtenances.

**5. The aforesaid fraud** violates the due process clauses of both the Constitution for the United States of America and the STATE OF IOWA (corporations) and also violate the equal protection of said constitutions.

6. I, **Johann Nikolaus Guido Franciskus Becker**, therefore claim and establish by this document that the said land and all appurtenances are held in allodia status and belong absolutely in all cases of whatsoever nature unto the said **Johann Nikolaus Guido Franciskus Becker**.

7. **Words of art** and numbers that produce the legal fiction, corporate fiction, dead person as a counterfeit, or any name derivation/deviation thereof that produces a counterfeit person as a corporation sole with or without the use of any trust identification number are hereby cancelled as name identity was done without disclosure and thereby fraud.

8. **You are now noticed:** Any person, party, corporation fiction, or any other using any of the counterfeit names, and not having Man's permission, gives its tacit approval and agreement that by using such fiction or counterfeit for its own or another's benefit, agrees to pay the sum of 20,000 Dollars, face value, in United States of America gold coin to: **Johann Nikolaus Guido Franciskus Becker, Man.**
