Pursuant to the Texas Public Information Act, Texas Government Code Chapter 552, I am requesting the following public records and documents related to the City of League City's recently adopted **Article V, "Vessel Residency and Nuisance Vessel Abatement"** to **Chapter 70 of the Code of Ordinances**:
